## REPUBLIC OF UGANDA CAR HIRE AGREEMENT

This agreement is drawn out on the 30<sup>th</sup> Day of September 2012 between two parties, on one part **ALPHA & BETA INVESTMENTS LTD** OF PLOT 3/5 BOMBO ROAD; P.O.BOX 5015, herein after referred to as "**Owner**" whereas on the other part, **Mr Jochen Meger** holding a German Passport Number C24N1FZXN driving with **Ms Marina M F Meger** holding a German passport number C24N43F7V the people hiring the vehicle, referred to as the "**Hirer**". **Tel number** 

The Owner agrees to hire out a motor vehicle (Toyota Hilux Surf) Registration Number UAR 890V and the hirer agrees to hire this vehicle by these terms below:-

- That the Hirer has checked the motor vehicle to his satisfaction and will not replace or substitute any parts or accessories of the hired vehicle without the consent of the Owner.
- ii. That the hired vehicle remains the property of the Owner.
- iii. That the Hirer pays a daily charge for all the period of hire.
- iv. That only the authorized Driver(s) drive the hired vehicle and any liability arising from the use of the hired vehicle by an unauthorized Driver is met by the Hirer.\*
- v. That the Hirer owes a duty of care for the hired vehicle, matters pertaining to the good maintenance of the hired vehicle, checking engine oil and other lubricants, water and security etc.
- vi. That in case of serious breakdowns of the hired vehicle, whenever necessary, the Owner will provide the hirer with a substitute vehicle as soon as possible for the remaining hire period. If this breakdown is due to an accident or a situation arising out of negligence due to lack of proper care / maintenance of the vehicle (like checking the engine oil, transmission fluids, water level in the radiator etc), the hirer will automatically loose his right to self-drive. He will be provided another car but with a driver and will be required to meet the driver's allowance of US Dollars Twenty five (US\$25) per day for the remaining rental period.
- vii. That the Hirer, is not allowed to cross any National border without the express written permission of the car owner.
- viii. That in case of an accident, the Hirer will make sure that he processes or clears a police report as well as meet all the associated costs related to its acquisition. The hirer will further be liable for costs related to bringing up the back-up vehicle and the rescue party as well as the fuel required for the return trip of the rescue party.
- ix. That the Hirer will return the hired motor vehicle on the agreed date unless the owner is informed and agrees on the desired extension.
- x. The Hirer will not use the hired vehicle for any sporting activities like racing or motor rally or to pull a trailer nor sublet the hired vehicle.

- xi. That the Hirer will provide fuel all the time the vehicle is in his custody and service the Vehicle regularly at the indicated mileages shown on the service card i.e changing of oils, filters, etc.) each 3,000 Km. He will also repair tyres' punctures.
- xii. The owner agrees to cover the vehicle with third party motor vehicle insurance, and always ensure that the car has a valid road license.
- xiii. The hirer agrees to take the vehicle at a daily amount of **United States Dollars**Sixty five (or the Uganda Shilling / Euro equivalent) per day for the hire period with full payment made at the start of the rental for the hire period.
- xiv. The Hire commences from 30<sup>th</sup> Sep to 13<sup>th</sup> Oct 2012. In case of any extensions, there will be a formal request for this by the hirer not later than one day before the end of this contract.
