The Home begun in 1970's to cater for venerable/orphaned Children and for the forty six years of existence over 2000 Children have passed through Toro Babies Home from the districts of Rwenzori region these are Kamwenge, Kabarole, Kyenjojo, Kasese, Ntoroko, Kibale, Kyegegwa and Bundibugyo. So we have old ladies and gentlemen serving in the community who would have not made it if it was not Toro Babies Home. The home has the capacity of sixty children this means we have entrance and exit since infants who need our care are very many in the Communities.

Since the Home begun it has been surviving on donors and local contributions.

- ❖ To place such children with foster –parents deemed necessary.
- ❖ To arrange for their adoption where necessary.
- ❖ To train young women and Men to take care of children in accordance with Religious ideas and self sustaining entrepreneur skills.

To engage in other activities as they may serve the aims and objectives.
